### Role of Surrogate Parent

- General responsibilities

#### Procedures for DFCS Involvement

- For students with disabilities under the protection of DFCS ("custody")...
- School personnel are responsible for:
  - taking steps to ensure student & parental rights are protected under IDEA regulations

### DFCS PROCEDURES for SCHOOL PERSONNEL

- Contact DFCS case worker to determine custody
- TEMPORARY CUSTODY
  - Confirm with DFCS if parents retain rights to make educational decisions
  - If court order revokes parental rights, parent may still participate in IEP process

#### PROCEDURES for DFCS PERSONNEL

- Contact district special education department to notify them of custody
- TEMPORARY CUSTODY
  - Explain parental circumstances of student in question
  - Determine if surrogate parent is needed

#### PROCEDURES for DFCS PERSONNEL

- PERMANENT CUSTODY parental rights have been voluntarily surrendered or terminated by court action
  - Child becomes ward of the state
- Surrogate parent should be appointed

#### ROLE OF DFCS

- DFCS caseworkers are not allowed to serve as surrogate parents for students under the care of their agency.
- DFCS caseworkers may:
  - Enroll children in general education
  - Make other decisions (medical care)

#### LIABILITY

- Georgia Law 20-1-.5
- Any individual appointed to act as a surrogate parent for a student pursuant to federal law and federal regulations, as such law and regulations existed on January 1, 1985, shall not be liable for any civil damages for any action or actions done while performing duty as a surrogate parent, except for acts or omissions to act constituting gross, willful, or wanton negligence.

### IEP CHECKLIST for SURROGATE PARENTS

- Before the IEP Meeting
  - Confirm attendance
  - Review parental rights
  - Identify topics for discussion

## IEP CHECKLIST for SURROGATE PARENTS

- During the IEP Meeting
  - Share information from parent perspective
  - Listen to staff observations & suggestions
  - Ask for clarification, if needed
  - Request summary of decisions made & confirm understanding of final recommendations

### IEP CHECKLIST for SURROGATE PARENTS

- After the IEP Meeting
  - Maintain contact with school personnel
  - Receive updates on student's progress
  - Be supportive
  - Attend any follow-up meetings, if necessary
