

For more than 35 years, Hall-Dawson CASA has had the privilege of serving and advocating for children experiencing foster care in our community. In 1989, we were one of two pilot programs in Georgia, beginning the journey that led to CASA affiliates serving all 157 counties in Georgia. We are proud to be part of such an impactful legacy.

In 2024, 103 Hall-Dawson CASA volunteers — like local high school basketball coach Seth Vining, pictured on the cover — served 317 of our community's most vulnerable children. For those children with a CASA volunteer, having that consistent adult in their lives leads to measurably better outcomes: they are much more likely to succeed in school and cross the graduation stage; more likely to receive vital services; and — **most importantly** — more likely to find a safe and permanent home.

The work of being a CASA volunteer is challenging: walking with children through the chaos of foster care is filled with plenty of frustrations, setbacks, and roadblocks that must be navigated. But the rewards make the journey worth it. Seeing a child find permanency — whether

through reunification, adoption or permanent guardianship — makes the journey worthwhile. In the words of CASA volunteer Tina de Waart, "My favorite part of being a CASA volunteer is seeing the children with parents who love them, who nurture them, and who keep them safe. I've seen first-hand the huge improvements in children from when they enter foster care to when they find their forever family. And I've seen the joy in the faces of these children when they know they are with a family who loves them. There is nothing better than that."

Our appeal to you is this: we believe that everyone has a role to play in serving our community's children. Whether you volunteer as an advocate, support us financially, serve on our board, or help us share our story, you can **BE THE ONE** to make a difference in the life of a child.

In the words of Buckminster Fuller, "It is always because of one person that all the changes that matter in the world come about. So be that one person."

Our Mission

To ensure children experiencing foster care because of abuse or neglect have the right to a safe placement and permanent home. CASA provides trained, screened and supervised volunteers to advocate for the best interest of children requiring court intervention as a result of abuse or neglect.

volunteers provided advocacy services for children in care

4,203 volunteer hours of service to children in Hall and Dawson counties

Community Supports Clothing and Toy (CAT) Center

The generous support of our community fills a gap for the children our CASA volunteers are serving. The CAT Center, located in the basement of The Little House, is a resource for our volunteers, DFCS partners and foster families to access gently used clothing, new toys, diapers and age-appropriate furniture. Community members, business partners and civic groups provide school supplies, which are collected and distributed before school begins in August, and toys at Christmas for CASA volunteers to "shop" for their kids.

Our CASA volunteers are creative when it comes to connecting and forming a bond with the non-verbal special needs children they serve. The phrase "show up" comes to mind. The more the children see the volunteer in different settings such as placement, school, medical appointments and so on, the more at ease they will be. So much is shifting and changing in their little world; the consistency of presence is a must!

CASA volunteer Amber always brings the same small stuffed animal every single visit. The child

recognizes it and looks forward to holding it. After a few visits, the child will rub it on their face or snuggle it during court.

Amber says, "I also use a 'thumbs up' and 'thumbs down' method to communicate if something is good or something is bad. For example, when you see the child laughing or clapping or smiling, give them a two thumbs up until they copy you. If the child is angry or sad, give them a two thumbs down and do it until they copy you. What you will find is that they will start using this to communicate completely





Consistent Belonging

Jana, a dedicated CASA volunteer, has spent countless hours advocating for children in the foster care system. Her involvement goes beyond the formal duties of a volunteer — she's become a trusted confidente and a comforting presence in the lives of the kids she serves.

One of the children Jana advocated for, a young boy who had been through multiple placements, had always been wary of forming connections. But over time, Jana's consistent care and support helped him heal and feel safe again. One day, after spending several months with Jana, he turned to his placement mom and asked, "Can I call her Grandma Jana?" The question came as a sweet surprise, showing just how deeply Jana had impacted his life. Her unwavering support had created a bond that felt like family.

For this child, Jana was no longer just an advocate — she was a symbol of stability, love, and hope. Through her efforts, Jana had not only made a difference in this child's life but had also shown him what it truly means to belong.

unprompted by you, helping you better navigate the mood they are in or what their preferences are.

"The main goal is to keep yourself regulated emotionally, and be a steady presence for their highs and lows. It can be frustrating for them to not be able to communicate or express how they feel with words.

"But most importantly, just show up. Your presence is the key to a successful bond with the children." Amber shares.

Consistent Guidance

Alicia, a college student who stayed in foster care after turning 18, was searching for an internship in social work. Her CASA volunteer helped her find an opportunity, provided guidance, and helped her pick out a professional outfit. They practiced interview questions together, and Alicia went in confident and prepared. Thanks to her hard work and Colleen's support, Alicia aced the interview and landed the internship! It was a proud moment for both, marking a big step toward Alicia's bright future.

2024 Financials

The condensed statement of activities reflects the fiscal year ending December 31, 2024, based on a preliminary audit. Hall-Dawson CASA prides itself on prudent financial practices, diversity of funding sources and the highest level of transparency. Operational costs include recruiting, training, and empowering CASA volunteers. Full financial statements are available upon request.
